## Local police, fire leaders to address FCA meeting on February 7

Arlington County Police Department Third District Commander Captain Adrienne Quigley will talk to Fairlington residents at the February 7, 2017, Fairlington Citizens Association meeting at 7 pm at the Fairlington Community Center. Capt. Quigley will discuss crime trends and traffic concerns and then open up the floor to any questions attendees may have.

Capt. Quigley has over 20 years with Arlington's police force and has served as the Third District Commander since 2015. Her past service includes patrol, the detective bureau, crime scene investigation, internal affairs, and, before her current appointment, tenure as acting Deputy Director of the county's Office of Emergency Management.

Capt. Quigley last spoke at a Fairlington Citizens Association meeting in November 2015 and reported then that Fairlington remained a very safe community despite a rash of car break-ins.

Also in attendance at the February FCA meeting will be Capt. Thomas Shamblin of Fairlington's own Fire Station 7. Capt. Shamblin will speak briefly to introduce himself and his crew and offer tips on fire safety.

Note that this meeting will be on Tuesday, February 7, rather than FCA's normal Wednesday meeting date.

# PRESIDENT'S MESSAGE

Residents often ask about business activity and real estate developments in the general vicinity of Fairlington. One of FCA's roles is to help keep the community informed about these and to offer answers to questions Fairlingtonians often have about them.

A series of lively exchanges on the Fairlington Appreciation Society Facebook page in the fall discussed the number of business closures and vacancies in Shirlington. We asked North Fairlington resident Rob Dietz, who has informally monitored Shirlington activities over the past couple of years for us, to check this out.

As his article on page 5 notes, Federal Realty Investment Trust, which owns and manages most of the retail space in Shirlington, remains pleased with the business environment in Shirlington, and several new businesses are slated to open in 2017.

Federal Realty points out that it is selective in the businesses that it chooses for Shirlington, with the goal of providing a good diversity of stores that will maintain the general character of the shopping district. But that also means that sometimes a storefront will sit vacant for longer than it otherwise might.

The big development activity in our area now is in Alexandria's West End. Sharing a border with Fairfax and Arlington counties, the West End is the City of Alexandria's largest and fastest-growing submarket and is getting major attention from the city council. The area is undergoing various revitalization efforts, with the future redevelopment of Landmark Mall and Beauregard Town Center, as well as the construction of the BRAC 133 office complex at Mark Center.

The Alexandria Gateway project, at the intersection of King and Beauregard Streets, is very much part of that special West End focus. The city council approved the final permitting for the project in late 2015, and construction is now getting underway.

Coupled with the construction of the Gateway development are major improvements to the intersection of King, Beauregard, and Walter Reed. Work on this project, particularly the utility relocation, is also getting underway. This will no doubt result in traffic congestion and disruption, but officials plan to keep the intersection open to traffic during construction.

The Gateway developer will address the community at the March 8 FCA meeting, and we may have a briefing by Alexandria staff later in the year on the bigger picture of activities in the West End. FCA will continue to monitor these nearby activities.

## New businesses coming to Shirlington

Changes are set for The Village at Shirlington in 2017 as new establishments are moving in to fill recent vacancies. In January Federal Realty Investment Trust, the company that owns and manages most of the real estate in Shirlington, announced several new retailers for the shopping center.

Two prominent closures occurred in 2016. The restaurant Luna Grill & Diner shut its doors in the fall. Representatives from Federal Realty indicated that there is interest in the space going into 2017.

Medi, Mediterranean Grill & Pitaria, closed in the fall as well. Expected to open in its place is Moby Dick House of Kabob. The restaurant is a D.C.-area chain focusing on Persian cooking with Mediterranean flavors. The business is expected to begin operations in the spring of 2017.

Additional openings in Shirlington will include Dudley's Sport & Ale, a bar and restaurant that plans a rooftop entertainment area. Taking over the old Bungalow space, Dudley's is expected to open in the middle of 2017 and is currently waiting on construction permits to improve and modernize the space.

Massage Forever, a high-end therapeutic massage spa facility, is expected to open its doors in the space previ-

ously occupied by CakeLove and Periwinkle in early 2017.

Finally, Adara Skin Care and Spa will open in the winter of 2017 where Mill End Shops was previously located. It will feature facials, waxing, and eyelash extensions, while a retail boutique within the spa will offer a range of skincare and makeup products.

Other vacancies, including the space previously occupied by Johnny Rockets, have received interest by potential new businesses.

Daniel Corwin of Federal Realty noted, "Retailers are doing well and sales are strong overall. And we're excited about the new businesses that are choosing to locate in Shirlington."

In a visit to FCA in October 2015, Mickey Papillon, Director of Asset Management for Federal Realty, emphasized that the company takes a strategic approach to filling vacancies in Shirlington, which can sometimes result in spaces being vacant for longer periods.

Rather than just slot any store into any available storefront, he explained, the company's goal is to "Find different and unique businesses that change and elevate the offerings for Shirlington."

There is also an optional "1K Walk & Fun Run" for families with small children. Dogs and strollers are always welcome.

The Silent Auction will be held Friday evening, April 21, in the North Fairlington Community Center. Last year's auction featured incredible items, such as a one-week beach rental in the Outer Banks; a weekend getaway at a ski condo in White Tail Resort; tons of local merchandise; Nationals tickets; and much more.

# 4MRV planning looks at park improvements in Shirlington/Nauck area

Highlighted by a series of popular hands-on public visioning workshops in December, a citizen working group and county staff are crafting a Four Mile Run Valley (4MRV) Parks Master Plan that includes the Shirlington Dog Park, the Jennie Dean Park and playground area, and the Shirlington Park exercise area south of Four Mile Run along Arlington Mill Dr.

Fairlington residents frequently use these park facilities. Although it is not part of the formal working group, FCA is informally participating in the discussions with county staff about improvements to these public facilities. All working group session are public and are held at the Trades Center Conference Center. Fairlingtonians are encouraged to attend.

The Parks Master Plan will guide the replacement and realignment of existing park features and the addition of new amenities to meet the growing demand for active recreation and cultural resources, as well as enhancing

## "Drop-in" session on Shirlington playground, Feb. 4

Come share your ideas about how to improve the Shirlington playground. FCA and the Arlington County Department of Parks and Recreation (DPR) are jointly hosting a drop-in listening session at the Fairlington Community Center on Saturday, February 4, from 10 am to noon.

Kate Thomas, the DPR staffer who is coordinating the planning for the playground and other aspects of Shirlington Park and Jennie Dean Park, will be on hand to get Fairlington residents' ideas on how to enhance the playground's value. She welcomes the chance to hear from children as well as parents.

Note that this is for the playground in Shirlington, not the Fairlington Park playground at the Fairlington Community Center.

natural resources. The Plan will be phased and incorporated into the county's Capital Improvement Program.

According to Kate Thomas, Principal Planner and Project Manager for the 4MRV Parks Master Plan with the county's Department of Parks and Recreation, the visioning workshops revealed broad support for balancing a variety of interests in the park area. "For example, there's strong interest across the board in natural resource preservation and better access to Four Mile Run itself," she says, with people viewing the stream as a key asset for the area. "Workshop participants want to 'do right' by the stream."

There was also strong support for the dog park, but there is a need as well to address streambank erosion,

stormwater runoff, and soil compaction, with workshop participants noting the need "to allow the space to heal." The working group will be examining multiple options for maintaining this popular dog exercise area while implementing a program that will help preserve and enhance the natural resources in the park planning area and allow better public access to the stream.

For Jennie Dean Park, workshop participants flagged the need to improve the existing diamond fields, which show the effects of thousands of hours of play each year. Their location in the park may shift, however. In addition, participants voiced support for the addition of a rectangular playfield in the parks master plan area.

Thomas is also actively seeking ideas for the new playground that will be built at Jennie Dean Park. FCA will be hosting a drop-in listening session on February 4 from 10 am to noon at the Fairlington Community Center for Fairlingtonians to speak with staff and offer suggestions for improving the playground.

Other ideas being explored for the 4MRV area include a potential community center that could serve as a venue for meetings, arts, and sports and recreation.

## A FiOS update from the Mews

Editor's note: The installation of conduit and PVC pipe in several South Fairlington condos has sparked a lively discussion on Facebook and around the community about the Verizon FiOS project. The Bulletin asked Renee Powlette, President of Fairlington Mews, for the perspective of one condo association on the process so far.

When I heard FCA was sponsoring a meeting with Arlington County and Verizon to discuss bringing FiOS to Fairlington back in January of last year, I knew the Mews had to attend to get the scoop. After years of people complaining about Comcast on the FCA's Facebook page, it was time for some competition to take the monopoly away from Comcast and potentially lower our costs in the Mews.

We learned that Verizon had signed an agreement with Arlington County back in 2006 stipulating that the company had 10 years to make FiOS available to all of Arlington County. We heard that FiOS was supposed to be superior to cable because of its potential for faster internet speeds. We also found out that Arlington County has a specific office to deal exclusively with Comcast and Verizon about service issues. Anyone who has a complaint should not bother talking to Comcast or Verizon but should contact the county staff and let them deal with it for you. It was all good news.

At our first opportunity, the Mews Board met with the Verizon contractor, and then later with several Verizon contractors to walk the property. We then signed the agreement to move forward with installation. We currently have the PVC pipe installed inside the fences of each individual unit and about a third of the outside

digging has been completed to install the backbone of what is needed to start service.

Verizon hasn't been the greatest with communication and we were surprised when they just showed up one day and started digging—and when they recently stopped digging and then started back up again. We had a few bumps along the road when people saw that the PVC pipe wasn't attractive attached to the fences inside the patios. However, everyone agreed to have it installed because installation at a later date would cost \$450 per unit. And in the Mews, we intend to bury the pipes within the next year, as we are slated to replace our privacy fences, where the PVC is currently attached.

Once the remainder of the digging is completed, the last step is to add our addresses to be eligible for service. I am hopeful we will see this before the end of January.

## County board endorses 395 HOT lanes concept

At its December meeting, the Arlington County Board endorsed in concept the proposed I-395 HOT lanes project to reduce congestion, provide additional travel choices, improve travel reliability, and improve roadway safety.

The county board particularly focused on aspects of the overall project that would enhance the movement of people, and not just vehicles, through the corridor by facilitating carpool and transit access to the Pentagon and by supporting new and expanded transit. The HOT lanes plan calls for at least \$15 million annually for transit alternatives.

The county board's resolution also asked the Virginia Department of Transportation (VDOT) to ensure that the final design of possible noise barriers "not unduly or negatively impact cultural or natural resources." Some residents in Fairlington will be asked to vote on whether they want sound walls installed. VDOT projects that the sound barrier decision will occur this fall or early in 2018.

# Construction to begin on Alexandria Gateway

Construction work was slated to begin in late January on the Alexandria Gateway project at King and Beauregard Sts., along with utility work that is associated with improvements of the intersection itself.

Excavation of the site is expected to continue for 10 to 11 months, with an average of 300 truck trips per day to take away the excavated soil. The site will then begin to be built out. Construction is expected to reach ground level about six to nine months after completion of the excavation.

The utility relocation work, which will precede the actual construction, will likely result in traffic disruption. However, the intersection will continue to be open to pedestrian and vehicular traffic.

Plans call for two apartment buildings, both of which will have ground floor retail, and an office building that also will have ground floor retail. Parking for the three buildings will be provided in a two-level underground garage.

The intersection improvements will include the undergrounding of utilities (the part of the project that will be occurring this spring), widening of King St., new medians, and the installation of wider sidewalks along both King and Beauregard Sts.

## Major changes slated for Landmark Mall

The slowly declining Landmark Mall could be reborn as a thriving mix of restaurants, shops, and apartments under a proposal being crafted by the developer of the property. Plans call for demolition of the two-story central area of the mall and replacement of this portion with a mixed use residential and retail complex that has a traditional street grid, sidewalks, trees, and open space.

In January, Macy's announced that it would be closing its Landmark location, and *The Washington Post* reported that the Howard Hughes Corporation, which already owned the central part of the mall, had purchased the Macy's property. The Sears store is under separate ownership and is not among the stores Sears recently said it would close.

The Howard Hughes Corporation envisions a walkable, mixed-used urban village that will offer 317,000 square feet of modern shops and restaurants, along with up to 400 new residential units and an updated parking structure.

In addition to the new retail and residences, the new Landmark will be an open-air community destination featuring multiple plazas and green spaces, outdoor seating, seasonal entertainment, and public art. The developer plans numerous full-service and fast-casual dining options, along with a 10-screen luxury cinema.

The company has not yet said how its acquisition of the Macy's property could change its overall plans for the mall. *The Washington Post* also reported that existing tenants in the mall had been asked to vacate by the end of January.

The Alexandria City Council approved an amended site plan for Landmark in June 2015. The Howard Hughes Corporation took over Landmark Mall in November 2010, and received initial rezoning approval for the redevelopment in 2013.

## Alexandria plans for school enrollment growth

Like Arlington County, the City of Alexandria is experiencing a significant growth in school enrollment, prompting plans for a new West End elementary school and major school redistricting. The result could eliminate some of the overcrowding at John Adams Elementary, which serves the Alexandria part of Fairlington.

This past school year, John Adams' K–5 enrollment was 890, compared with official capacity of 634. In percentage terms, it was the most overcrowded elementary school in Alexandria.

According to Alexandria City Public Schools (ACPS), enrollment in Alexandria's public schools has been growing an average of 500 students per year since 2011 and is expected to continue growing through 2030. Across the school system, only two schools are not currently at capacity.

To accommodate this growth, ACPS has developed a long-range educational facilities plan to address capacity issues and building condition needs. The system is also developing options for redrawing school boundaries. That redistricting process is in its final stages. A decision on new school district lines was expected in late January.

Under the options currently under review, Fairlington

students would continue to be assigned to John Adams, so redistricting would result in no new school assignments for them.

In December, the school board approved funding to buy and renovate a building at 1701 and 1705 N. Beauregard St. to serve as a new West End elementary school. The estimated purchase price of the building and adjacent garage (which would be converted to outdoor space for students) is \$15 million. School officials estimate that it will cost an additional \$23.2 million to retrofit the building. These funds have already been budgeted.

Creation of the new West End school would help add 638 seats to school capacity in that part of Alexandria, relieving enrollment pressure on John Adams.

Both the new West End school and the new redistricting lines are likely to be implemented in time for the start of the 2018 school year.

Thomas notes a near-universal call for additional parking for users of the park areas. The challenge, she says, is how to provide that without "gobbling up" valuable park space.

Edie Wilson, President of the newly formed Shirlington Civic Association, applauds the county's focus on the Four Mile Run Valley. "This project is vital to our future. Shirlington residents are in these park areas all day long, strolling, walking dogs, and exercising. We pitch in to pick up litter and keep an eye on things. We are working hard to ensure that the final result honors the diversity and history of our valley and balances natural resources and stream restoration in the flood plain with recreation facilities that everyone can enjoy. Additional parking in the 4MRV project area is essential—new programs will increase visitors, and we can't have them all parking in Shirlington."

The current timeline calls for the county board to consider the policy framework for the 4MRV initiative this summer, with the adoption of the Area Plan and Parks Master Plan to occur early in 2018. 



## Sidewalk improvement projects move forward

Several street and sidewalk improvement projects in the Fairlington area are nearing approval as part of the county's Neighborhood Conservation program.

In December, the Neighborhood Conservation Advisory Committee (NCAC) endorsed plans to install a sidewalk along the east side of S. 31st St. from the bus shelter across from the Shirlington House apartments to S. Randolph St. Currently there is no sidewalk on that side of the street.

As part of the improvements in this area, the NCAC also recommended the replacement of the existing Cobra street lights with Carlyle lights along S. 31st St. from S. Woodrow St. to S. Randolph. That will make those street lights consistent with the style of street lights used in Shirlington and other parts of Arlington.

FCA indicated its support for these two projects back in the fall. The Arlington County Board is expected to approve these plans at its February meeting.

With those projects moving forward, the next Fairlington item on the NCAC agenda will likely be a proposal to install a sidewalk along the north side of S. Abingdon St. between S. 31st St. and S. 31st Rd. This improvement was included in the Fairlington-Shirlington Neighborhood Conservation Plan update, which the county board accepted in 2013.

The need for a sidewalk in the area has also come up in discussions over the expansion and renovation of Abingdon Elementary.

County staff met with Fairlington Villages condo staff and NCAC members in late December to discuss options for installing the sidewalk. In recent years, the Fairlington Villages condo association installed and maintained plants and landscaping on that side of the block.

While the condo's landscaping would not be significantly affected by the sidewalk installation, two existing parking spaces would be eliminated from the street to make room for the sidewalk, which would be built at street level next to the small hillside in that block.

The Fairlington Villages condo board approved the sidewalk installation at its January meeting, and FCA gave its endorsement in January as well. The project will be slated for consideration in the spring round of NCAC projects.

Fairlington resident Anne Wilson, joined by Master Gardeners from across Arlington, made a short presentation to the board, stressing the group's work on sustainable landscaping. "We're here to work with the communities...to ensure that everyone has the health, including mental health, benefits of a sustainable landscape throughout the county."

The work is expected to be done this spring. The project is funded by private donations.

# DOWN TO EARTH patio gardening



## Cultivating a winter garden

February is the most challenging month in landscape design. There's nothing on the nursery lots but gravel and heated bubbles which house evergreen plants. A garden's soil usually is frozen, so if one wanted to plant, there'd be digging through four to five inches of frozen tundra before reaching malleable dirt.

Annuals have been spent for two months, perennials are in dormancy and Pansy flowers are alive but wilting and shriveled. Rosebushes finally have dropped their leaves and now offer only thorny woodwork.

For residents who want a 12-month presence in their garden, there are plants to incorporate that will make it worthwhile to sit outside in your patio, nurse a mug of coffee, and admire a winter landscape.

**Dwarf Nandina**: It has the shape of a large, busy egg and the leaves of some cultivars turn a vivid red in cold temperatures. 'Firepower' is the classic cultivar that will catch your eye from 50 yards. Don't believe me? Drive through Shirlington (near the post office and the gas station) and notice a bank of these planted near the gas station sign. Whether it's below zero with the wind chill or snowing, Dwarf Nandina leaves remain erect and persist in color. And they're practical for a Fairlington patio since each one is 16 inches tall with a 10-inch spread.

**Nandina Domestica**: If fruit is what you want, plant one of these. This specimen grows six-feet tall with a

four-foot spread. It's evergreen and bears huge clumps of red fruit with maturity. When color is devoid in the winter months, this plant's fruit is showy. There is a cluster planted at the traffic circle where S. Stafford St. meets S. 36th St. in South Fairlington.

Winter Creeper Euonymus: This ground cover evergreen grows laterally and fills the vacant space in your garden. In colder months, the small, oval leaves become pink on the margins. It gets leggy and sometimes tangled but may be easily pruned so its vines don't ramble onto other plants.

**Dwarf English Boxwood**: This small, stately evergreen that stands tall in winter but is only 20 inches with a 14-inch spread. The tiny, oval leaves are tightly formed in a dense habit the shape of an egg. Boxwoods look pretty when planted in a row or in a cluster.

Thread Leaf Falsecypress: The flimsy branches are delicate and lacelike. The 'Filifera Aurea' cultivar offers muted yellowish foliage. Purchase the dwarf version, which grows less than two feet tall with a similar spread. The pendulous habit is quite unlike any other specimen—most of which have stiff branches growing upward.

**Camellia:** 'Japonica' is the winterblooming cultivar. It bears four-inchlong, shiny leaves year round and shows a rosette-like flower in winter. Varieties bloom in different months during winter. Flower colors come in red, pink, and white. Each 'eye' (flower center) is yellow. Before the flower blooms, notice the one-inchthick bud (like the Rhododendron) that clings to a woody stem.

For a fall-blooming Camellia, look for the 'Sasanqua' variety, which has a smaller, two-inch-long leaf. Camellia is a stiff-branched specimen that has the shape of an open hand. So it situates well against a patio fence or the brick wall of a Fairlington building. Camellia will reach five to six feet tall with a narrower spread.

Rug Juniper: This cultivar is a clumped plant growing only 8 to 10 inches tall with a wider spread. It is evergreen and has a 'Wedgewood' blue foliage, similar to that of a Blue Spruce tree. Rug junipers take up little space in a garden and are extremely heat tolerant key in our hotter weather (May into October).
